We're pleased to continue programs introduced in 2023 to help us further support and recruit participation from our local agricultural community.

EARLY BIRD RATES FOR GROWERS

Farmers and Growers – get your applications, supporting documents and payment in early to secure last year's vendor rates! Completed grower applications, registration fee and vendor fees must be submitted before end of day on February 15, 2024 to receive the early bird discount. Cheques will be cashed upon acceptance to the Market.

***NEW* 'UNIQUE' VENDOR REFERRAL BONUS**

Know a grower or small batch food producer you think would be a great fit for our Market and would help fill gaps/diversify offerings in Waterdown? Encourage them to apply and indicate they were referred by you (your business) on their application. Referrals for accepted full season vendors in underrepresented categories will earn referring vendors a \$75 bonus; referrals for accepted half season 'unique' vendors will earn you a \$40 bonus.
